PURPOSE:

This guideline was promulgated to establish procedures for requesting to take a District Vehicle and/or Apparatus out-of-Town to enable the Chief of Department and his/her designee(s) as well as the BOFC Chairperson to be fully aware of the location of vehicles and apparatus at all times.

SCOPE:

All personnel of the LFD.

PROCEDURE:

- 1. Personnel electing to take a District vehicle and/or apparatus outside the boundaries of the Township of Lakewood shall have their respective Company Officer or his/her designee complete a Request to Take Vehicle and/or Apparatus Out of Town form. (Separate forms shall be submitted for each vehicle or apparatus being requested to be taken out of Town).
- 2. This form shall be completed in its entirety and explicitly indicate:
 - a. vehicle and/or apparatus being requested
 - b. members who will be in attendance
 - c. date, location and time/length of event/activity
 - d. reason for the request
- 3. The Company Officer or his/her designee shall submit the completed Request to Take Vehicle and/or Apparatus Out of Town form to the Chief of Department for his/her approval.
- 4. Once the Chief of Department or his/her designee signs the request form indicating approval, the Request to Take Vehicle and/or Apparatus Out of Town form shall be submitted to the Board Office for authorization.
- 5. Once the Board Office has provided authorization a copy of the approved Request to Take Vehicle and/or Apparatus Out of Town form will be electronically provided to the BOFC Chairperson, all Chief Officers as well as to the Company Officer who made the request.
- 6. Please note approval of the BOFC Chairperson is mandatory for requests beyond the contiguous municipalities of the Township of Lakewood as well as for all out-of-State requests. For this reason, it is imperative that requests be submitted as soon as possible. Last minute requests may not be authorized.
